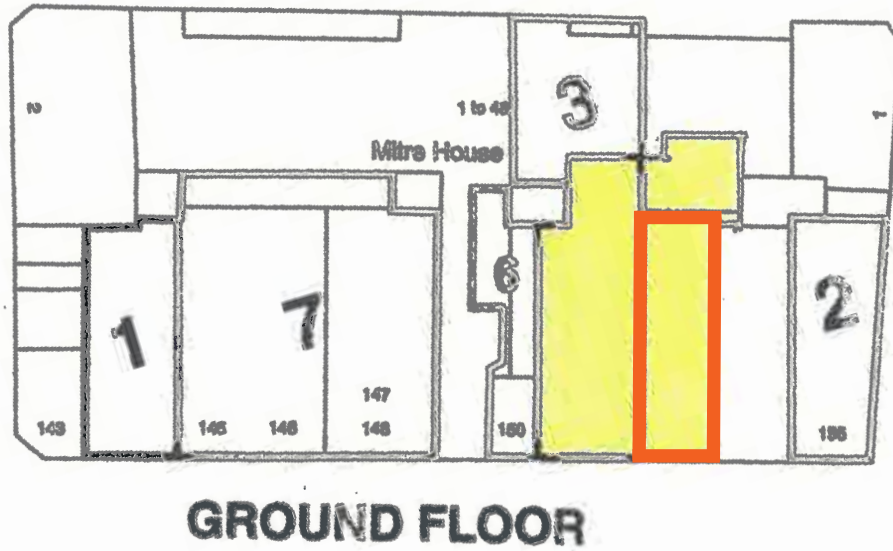

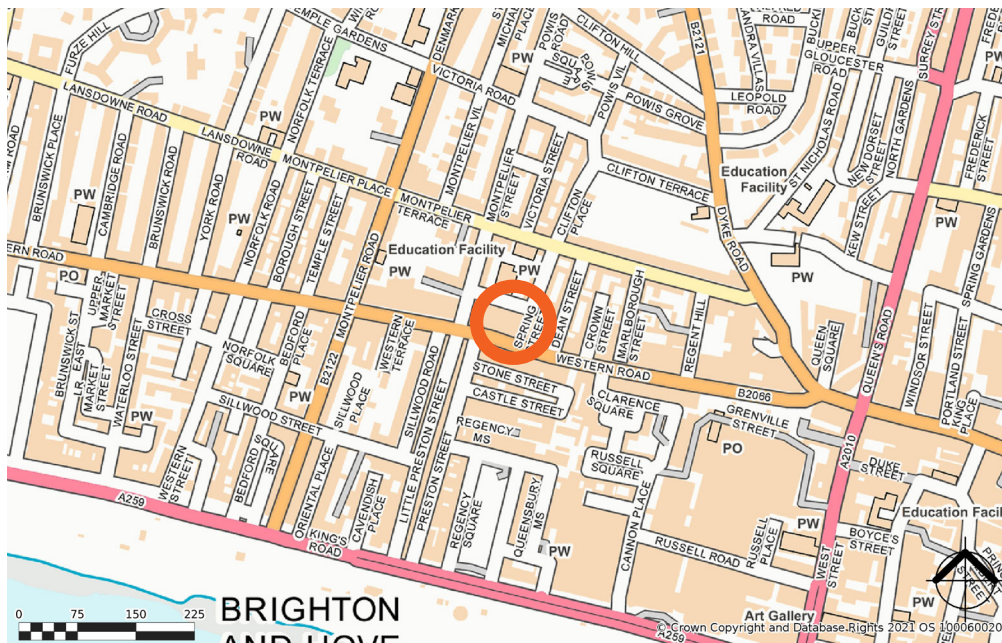

Floor Plans

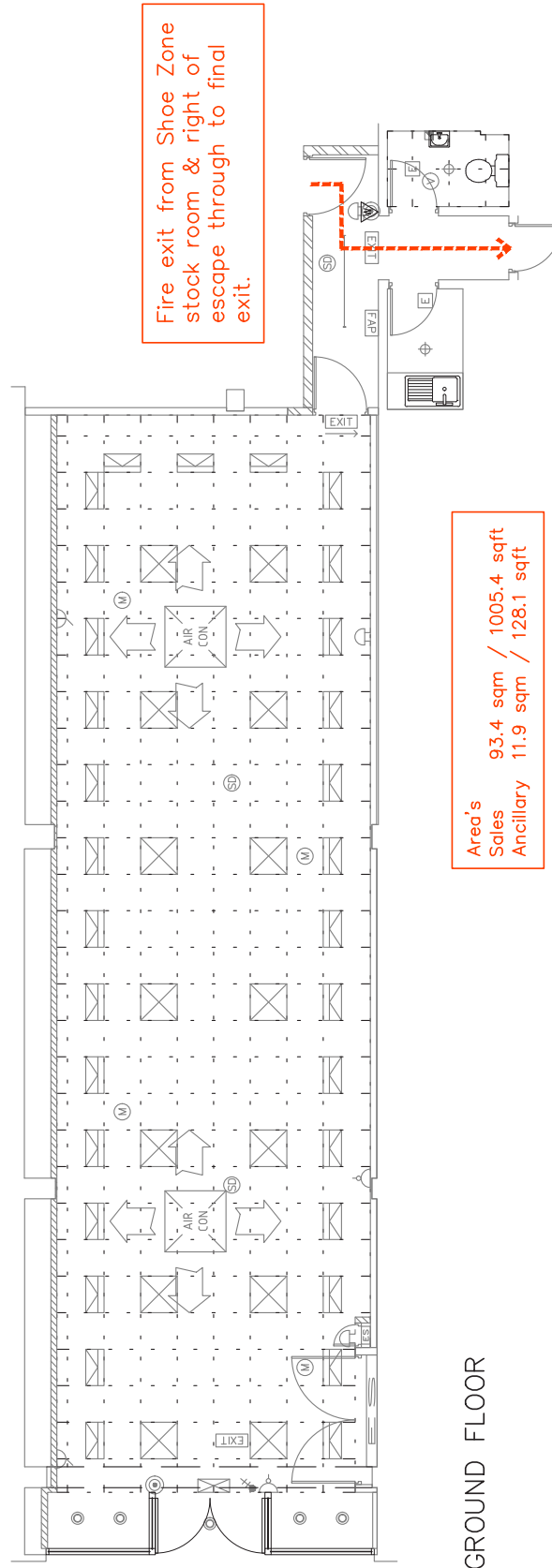


Location Map

Location

The property is situated within an established trading location on the northern side of Western Road close to Preston Street, just to the west of Brighton City centre and Churchill Square.

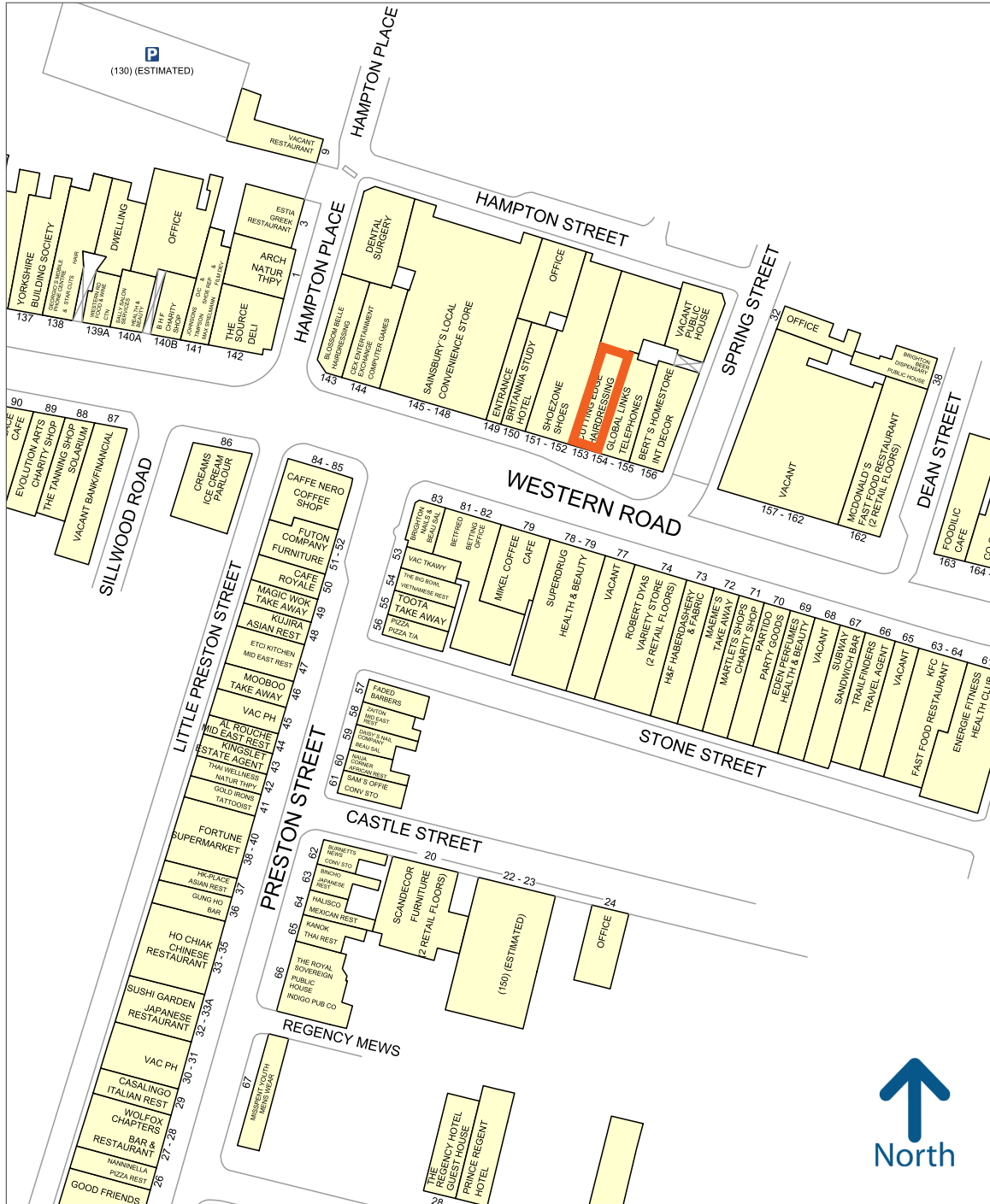
