





Location

Southwick lies approximately 4 miles west of Brighton city centre. Ocean View Business Park is located on the northern side of Gardner Road within a 5 minute walk of Fishersgate station.

The A259 South Coast road is situated approximately 150 yards to the south, whilst the A270 Old Shoreham Road is easily accessible a short distance to the north from which access can be gained to the A27, the M23 and the national motorway network beyond.

Description

The subject unit comprises ground floor accommodation situated on the southern side of this two-storey purpose built commercial building.

The front unit has been recently refurbished and made open-plan with a roller shutter at the front (approx. 5.5m x 4m). The eaves height throughout is approximately 5.15m.

There are communal WCs and if required, a kitchen can be erected within the space.

Planning

A new Use Classes Order (UCO) came into effect on 1st September 2020. Under the new UCO a new Use Class E was introduced to cover commercial, business and service uses. Use Class E encompasses A1, A2, A3, B1 and some D1 and D2 uses under the former UCO. We therefore understand that the premises benefit from Class E 'Commercial Business and Service' use within the Use Classes Order 2020.
